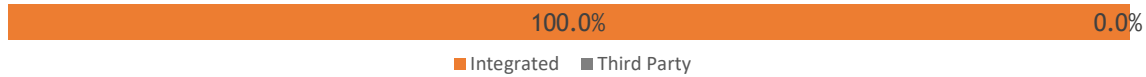

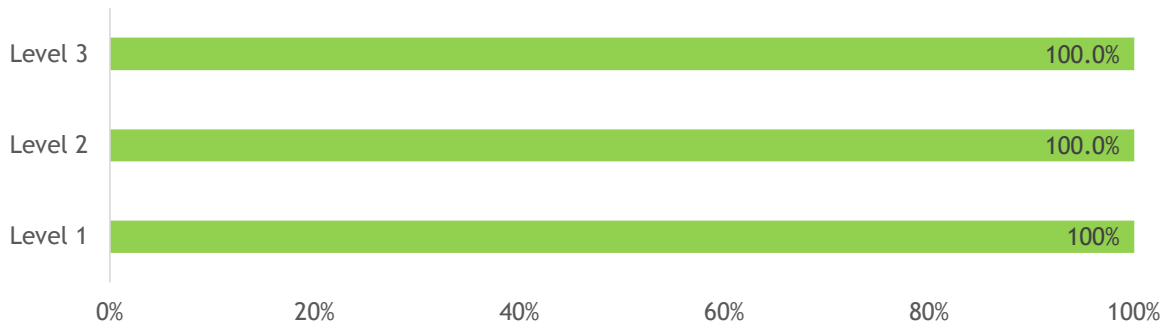

Total - NR Traceability



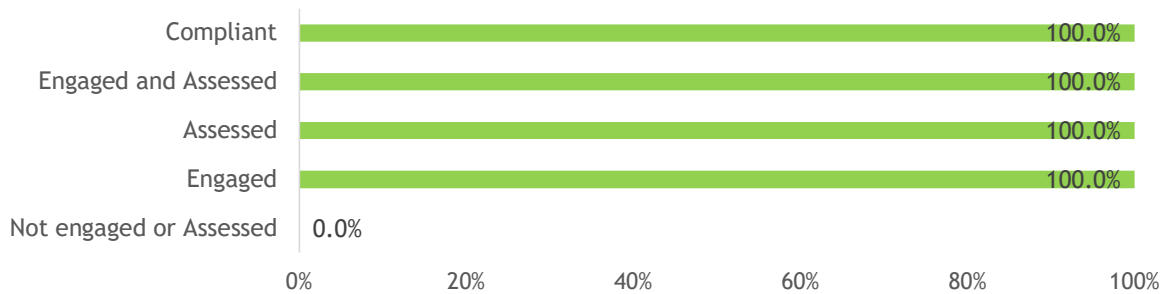
Definitions

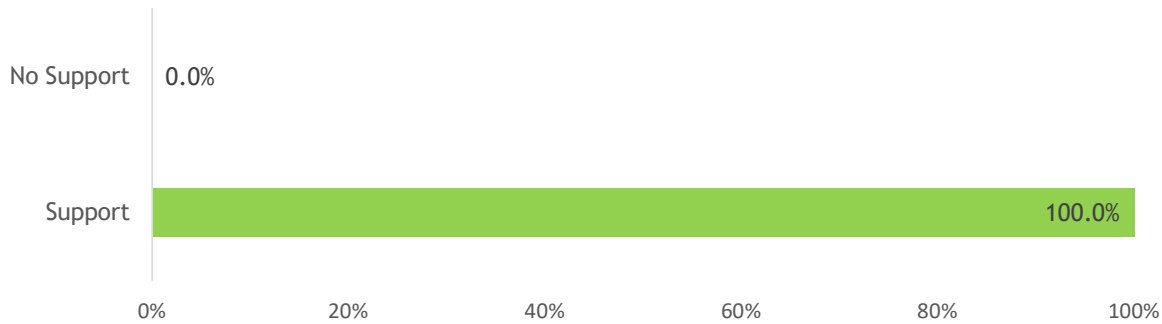
Defintions
